

LIMITED WARRANTY TERMS AND CONDITIONS

KUBS SAFES AND LOCKS PVT LTD., warrants your product (s) against Product Serial No's issued to be free from defects in materials and workmanship under normal use for a period of 1 (one) year/s from the date of purchase, as evidenced by the purchase receipt. The obligation of Kubs Safes and Locks Pvt. Ltd under this Warranty is contingent upon proper use, installation, and maintenance of the safe.

During the warranty period, KUBS SAFES AND LOCKS PVT LTD., the following are covered:

- Defects in Materials and Workmanship including all welding, steel fabrication, interior door defense mechanism and safes' interior.
- Paint and finish subject to the product being placed in a climate and humidity-controlled environment.
- Combination locks and key locks are covered under a limited one-year warranty from the respective lock manufacturers.
- This Warranty is void in the event that any repairs to the product are affected, other than by Kubs Safes and Locks Pvt. Ltd, without the prior written consent of Kubs Safes and Locks Pvt. Ltd. This warranty is void if the product is damaged due to wear and tear and/or other consequences such as water damage.
- No Kubs Safes and Locks Pvt. Ltd employee, agent, representative, or dealer has the authority to make
 or imply any representation, promise or agreement that in any way varies the terms of this Limited
 Warranty.

KUBS SAFES AND LOCKS PVT LTD., products warranty does not cover:

- Damage due to acts of God, accident, misuse, abuse, negligence, improper installation, or failure to follow maintenance and operating instructions provided.
- Any deliberate physical damage to the product. The product should be fixed within a secured environment.
- Any damage/losses happened/incurred to/by the user including theft due to breakthrough of safe using the security key/pin/password/combination code or security system breakthrough via any physical damage to the Safe.
- Defects caused by modification, alteration, repair or service of the product by anyone other than the manufacturer or its authorized representative, or by physical abuse to or misuse of the product.
- Any liability for defects or damage caused or increased by the use of unauthorized parts.
- Normal wear, battery replacement (where applicable) or combination lock change without factory approval.
- Costs for removal or installation of the product or its contents.
- Any personal property stored inside the product
- Damage to the product incurred during shipment. The product was packed in accordance with the requirements of the product specifications, and with reasonable handling, should be in good condition on arrival. Any claims for shipping damage should be made directly to the carrier.
